

Tribal Youth Court, TYC, aims to cultivate wellness-based responses to low status offenses. The TYC centers on educating tribal youth about tribal restorative justice practices and empowers them to engage in these practices in service of their communities.

## Hello Readers,

Exciting news ahead! After a fantastic turnout at the October Peer Decision Maker (PDM) Training Workshop, we have decided to host these quarterly. The workshops will be held every quarter, and will complement our Honors Program courses that span the academic calendar year.

Our Honors Program courses and training workshops are curated to provide a comprehensive understanding of tribal restorative justice principles. The training workshop is specifically designed to provide participants with knowledge of the Intertribal Court, the Tribal Youth Court, and the broader experience and expectations associated with being a PDM. The primary objective of the training is to equip participants for their roles as peer jurors. The workshop covers all phases of the PDM responsibilities, beginning with the pre-hearing conference and concluding with a mock hearing, where participants actively contribute to defining the parameters of TYC participants' wellness plans.

All workshop participants who complete the training will receive a Certificate of Completion. Furthermore, participants will earn community service for their dedicated time during the training.

Quarterly trainings for 2024 are tentatively scheduled for February, May, August, and November. Concurrently, our PDM Honors Courses will begin in February at SDSU, continue in June at Palomar College, and conclude with the last two courses starting in October at UCSD. We encourage you to explore both training options and become a part of this transformative experience!

## December 5th:

International Volunteer

Day This day is an international observance to recognize the efforts of volunteers in transforming communities and societies. It is celebrated by many individuals and organizations around the world. How can you celebrate?

## <u>December 7<sup>th</sup></u>: National Pearl Harbor Remembrance

Day This day is commemorated to honor the service men and women who were killed or injured when Japan attacked the U.S. at Pearl Harbor. The attack claimed 2,400 lives on December 7, 1941. It precipitated the U.S. entry into World War II. This is not a public holiday, but many government and public offices hold special events to commemorate the annual observance.

## Frequently Asked Questions Ask the court >>>

**Question:** What if a youth is not eligible for the Tribal Youth Court?

**Answer:** Several factors could render a youth ineligible, with two primary reasons being the age of the offender and the nature of the committed offense. Presently, the Tribal Youth Court is undergoing expansion to address such cases by introducing two additional tracks under the TYC. One track aims to accommodate youth involved in more severe offenses, and the other is tailored to formulate age-appropriate wellness plans for offenders aged 18-24. Both tracks are pending the implementation phase, but are expected to be fully operational next year. Stay tuned!
