ADOPTION OF FINE SCHEDULE AND MODIFICATIONS AND ADDITIONS TO LAW AND ORDER CODE OF THE LOS COYOTES BAND OF CAHUILLA AND CUPENO INDIANS

WHEREAS; Los Coyotes Band of Indians is a federally recognized reservation who are governed by our customs and traditions and,

WHEREAS; The Los Coyotes Police Department is a Federally Deputized Police Agency, employing Police Officers holding Special Law Enforcement Commissions issued by the Bureau of Indian affairs and,

WHEREAS; The need to protect the safety of persons residing within, or visiting the Territory has a direct effect on the political integrity, economic security, and heath and welfare of the Tribe, and,

WHEREAS; The Los Coyotes Band of Indians is a member Tribe of the Inter-Tribal Court of Southern California and desires to prosecute violations of the Los Coyotes Law and Order Code in the Inter-Tribal Court, and,

WHEREAS; The Los Coyotes Band of Indians finds a need to clarify and make additions to the Law and Order Code of the Los Coyotes Band of Indians, See Attachment 'A' for clarifications and additions contained in Fine Schedule.

WHEREAS; To levy penalties in the Inter-Tribal Court, and by the Los Coyotes General Council when acting as the Tribal Court for the Los Coyotes Band of Indians, there necessitates a formal and uniform monetary penalty and fine schedule and,

WHEREAS; The Tribe desires to adopt the Violation Fine Schedule and clarify and add additional and specific violations to the Law and Order Code referenced to in ATTACHMENT 'A' to the reservation, applicable to non-members and members and,

LC COYOTES BAND OF CAHUILLA D CUPENO INDIANS VIOLATION FINE SCHEDULE

All violations below are found in the Law and Order Code of the Los Coyotes Band of Indians

The civil penalties listed below may be tripled by the Court in any case where the person receiving the civil citation willfully and maliciously, or with gross negligence, causes physical harm to another person. The Court may reduce fines or assess maximum (3rd Offense) fines for exceptional circumstances. Upon 3rd Offense or decision of Tribal Council, offender may be excluded from the reservation.
